According to tax experts that ISC has consulted, German drivers of business cars (employed as well as self-employed) give away more than 1 billion Euros annually to the German state because they don't report by use of a drivers' log. A large number of these drivers could save a lot of tax payments by reporting the actual mileage instead.

All self-employed (Freiberufler and Selbständigen) must, according to the new 2007 rules, use a driver log for their business car. Many business owners believe this is a complicated and time-consuming task to fill out a manual drivers log book.
